S.M.U.D. (Sacramento Municipal Utilities District) has an "Upper American River Project", that they are trying to attach to the application to renew their lease, for the use of the American River. Leases are now granted for 30 years, but if they can get this project attached, they could get a lease for 50 years. There is a 137 page document describing the project at:

## **Wood Chipping - Clear for summer**

At our community meeting on June 11, we have a guest Vicki Yortv. speaker. from the El Dorado County Fire Safe This is an program. excellent program, to help residents get rid of brush on their property, helping to avoid quick spreading forest fire. There is a lot of terrific information on their website. www.edcfiresafe.org

Vicki will explain to us how the program works. Thev encourage cuttina defensible space of 30 -100 feet from buildings and 20 feet from roads. We will have them come out in June to chip the vegetation vou have cleared and stacked. You do not need to be home, on the date of the chipping. They will also provide а green

dumpster for you to throw away your needles, grasses and such, that can't be chipped in the chipper.

They are specific on how the




branches must be stacked, and where. See picture below

- Place brush piles so the chipping machine and crew can have access.
- 2. The piles must be adjacent to a driveway or street.
- Cut ends must all face the same

- direction and facing the driveway/street.
- 4. Make piles wider and more spread out, rather than tall.
  - Freshly cut vegetation chips easier than old branches.
  - 6. The chipper can handle material up to 7" in diameter, but NO root balls.
  - 7. Keep piles free of rocks, dirt, wire, lumber, spiny plants (blackberries), pine needle piles, leaves, and NO POISON OAK!!

## Free Vegetation Removal for Seniors! - Clear for Summer!

### Free Vegetation Removal for Seniors and Disabled in El Dorado County

This program may be temporarily on hold, until funding comes through, but you may fill out a request form in the meantime!

Requirements: You need to be 60 years of age or older and/or disabled and need assistance with clearing around your home in order to meet the required 30 feet of fire safe clearance. The residence that needs the clearing work must be your primary residence. There are no financial qualifications required to be eligible for this program, however this program has limited funds so please use this service only if you are financially unable to pay yourself.



**How the program works:** Once the form is submitted you will be contacted by the El Dorado County Fire Safe Council and arrangements will be made to have vegetation removed 30 feet from your home. This service is a pilot program funded thru grant money received from El Dorado County, Title III funds. Due to limited funds, this program is on a first-come, first-served basis. This program is extremely popular, so it may be a few weeks before you can be scheduled to receive assistance.

The clearing work will be done by a landscaping crew from Mother Lode Rehabilitation Enterprises (M.O.R.E.), or another contractor. The crew will rake, weed-eat grass, remove accessible brush and other woody debris, from around your home and the El Dorado County Fire Safe Council will pay the bill. Large trees that need to be removed will be the homeowner's responsibility.

**Cost:** The clearing work is FREE.

## Iowa Hill-Continued from page 1

Anybody that has lived in the city knows that the city doesn't become city, all at once. Piece by piece, parts of the country were eaten up. That's what's happening here, not to mention possible "issues" with us getting more water for El Dorado County, in the future.

The good part? It's all good for the Sacramento Valley, they'll have more energy to burn. Everyone is in favor of cleaner energy, there is no argument there. The good for us? None.

The problem? Per SMUD's "Socioeconomic Assessment", problem number 1.)SMUD will no longer allow access to this area because of "Potential risk of injury to the public." 2.)they will be permanently changing the scenery, by clearing 150 acres of timberland and topsoil near Slab Creek/ lowa Hill. 3.) The construction will last over five years, adding more than 830 construction personal over the 5 year construction period. Most of this traffic, per SMUD, will be on North Canyon going to Slab Creek from 5:30am to 4:30pm. They say it won't impact us, but that's 1/3 of the population of Camino! This traffic will include various construction vehicles, including large equipment. Think of Apple Hill traffic with that mess. The worst part about it? 4.) El Dorado County doesn't get to have any say, as to whether or not they want this happening, because it's Federal Land. The county can only give permission or not, to utilize the roads during this construction. And all this is for what?

What do we do now? Is it completely hopeless? Well, that's up to each and every one of you. We can't expect just a handful of people, like the Camino Action Committee, to fight the battle for us. The question is "what is worth to you?" Do you think our quality of life or home values could change with this project? A letter writing campaign can at least let our voices be heard. You can state your feelings. Would you like there to be access to the river? Do you not want the area cleared out for this project? Or, should there should be some benefits to El Dorado County residents?

F.E.R.C. (the Federal Energy Regulatory Commission) is the group that will be approving the relicensing of SMUDS use of the river, with this project attached, for the next 50 years. Acres of land owned by SMUD are 109, NFS (National Forest Service) is 190 and SPI (Sierra Pacific Industries) owns part of the land that will be used for transmission lines and additional access.

Where to write? Here are the addresses. We encourage you to take an active part in your community. Many people say, "well, we'll just move if it gets bad." But...this is happening everywhere. # **Protection against Mosquito's**

- Mosquitoes are scientifically classified as "True Flies". they have two wings. Mosquitoes use carbon dioxide, moisture, color, and movement to help locate their prey. The U.S. Department of Agriculture is studying hundreds of naturally occurring chemical compounds on human skin to try to isolate which ones appeal to mosquitoes. Until they do, here are practical and not so practical ways to deal with the little buggers.
- When possible, wear longsleeves, long pants and socks when outdoors, even if it's 100°!

Rash of bird deaths-West Nile?

- Consider staying indoors at dawn, dusk, and in the early evening, which are peak mosquito biting times.
   Basically, never go outside when it finally cools down!
- Spray clothes only, not skin, with repellent containing permethrin or DEET, to help ward off mosquitoes.
   Pray you don't grow a third arm from the DEET.
- Place mosquito netting over infant carriers when you are outdoors.
- Install or repair window and door screens so that mosquitoes cannot get indoors.
- At least once or twice a week, empty water from



flower pots, pet food and water dishes, birdbaths, swimming pool covers, buckets, barrels, and cans.

- Check for clogged rain gutters and clean them out.
- Be sure to check for containers or trash in places that may be hard to see, such as under bushes or under your home.

Because of the danger of the West Nile Virus, which is transmitted from mosquito's to birds, please report to the number below.

# What is West Nile Virus?

West Nile virus (WNV) is a mosquito-borne disease that is common in Africa, west Asia and the Middle East. WNV is a potentially serious illness. Experts believe WNV is established as a seasonal epidemic in North America that flares up in the summer and continues into the fall.

We have had some reports of bird deaths, discovered again here in Audubon. This causes us great concern for our wildlife, but also for ourselves and our pets as well. Some homeowners have found up to 7 dead birds on the property! If you do come across one, contact the West Nile Information Group at the number provided above. It is best not to handle the dead bird with your bare hands. Call them to see if they wish to come pick it up. If not, use gloves, a shovel, and a plastic bag to dispose of the bird.

Due to the high volume of reports to the hotline, the California Department of Health Services is unable to respond to each report. However, all of the information received about dead birds is used by public agencies to track where birds are dying. Dead birds are an indicator of West Nile virus activity. This allows the local mosquito and vector control agencies to concentrate mosquito control efforts in those areas. Thank you for each and every report. Those reports will help them protect us from the West Nile, especially if it seems there are a high number of dead birds found in our area.
